1239. Planning:

1240. Finance:

a) Authorisation of Accounts: The following payments were presented for payment and approved:

- b) Due to vision problems, Gordon Camble has had to resign as internal auditor. A new internal auditor will be appointed at the next meeting.
- c) An up-to-date list of assets will need to be drawn up at the next meeting.
- d) Cllr Dean enquired into whether councillors can be re-imbursed for their printing costs.

1241. Fields in Trust:

The old Stamco ground, now under private ownership, could possibly be restored to a useable sports field thereby returning it to the community. Clerk to approach owner to see how the Council can help in this matter whether it be via fields in trust or through buying the land.

1222. Parking on Grass Verges:

The previous suggestion of having planters in place was deemed to pose a possible risk of accident or injury. The planting of trees or installation of flower beds was agreed to be a more acceptable alternative. Clerk to approach ESCC to seek advice on types of trees that would be most suitable.

1222. Code of Conduct:

After discussion and comparison of two codes of conduct it was agreed unanimously to adopt the Rother District Council Code of Conduct.

1242. Pett Cricket Club:

Cllrs Dunlop and Stapley re-iterated their interest in the following item. Pett Cricket Club would like to build a new pavilion, possibly with the help of Fields in Trust or the Community Grant Scheme. The Council is in support of improving the condition of the pavilion, which is used by different sports, not only the Cricket Club.

1222. Correspondence:

The clerk reported on correspondence received since the last meeting.

1243. Parish Matters:

- a) Amenities No report
- b) Footpaths The bracken on the verge outside 'Bracken' has still not been tackled. Clerk has approached ESCC and is awaiting a response. Paul Norris has cleared the footpath opposite the church. The Council expressed their thanks for this.
- c) Highways A representative from Rother will be coming to look at the hedges causing a problem: Cllrs Dunlop or King will meet him to show them the specific areas and discuss the issues. Marc Fleischer, the landlord of the Two Sawyers has offered to cut the hedge beside his property (even though it is not his responsibility) in order to help with visibility along Pett Road. Resurfacing of some areas of roads in Pett will commence in September
- d) Community Safety A rota for inspection of the play area is in place. Dog waste bins are still being misused.
- e) Environmental issues none
