Pett Older Peoples Project – Now that Popp is one year old it is nearing the end of its lottery grant

and entering in to a period where it will try to obtain financing. It has grown from 9-39 members. The annual cost of running Popp is approx £18,500 gross. Labour costs, hall rental, food, equipment and transport all represent significant costs. To raise funds Popp holds raffles and have a bring and buy table. Some members are living on small pensions and for many it is their only outing throughout the week. Paul Brown from Guestling Council recently donated £150.00. Popp will be holding a Christmas party on the Tuesday before Christmas (18th)

1292. Planning:

c) Highways – The clerk has written to Southern Water again and was informed the leak is a drainage problem, for which Highways is responsible. Highways have been approached.
d) Community Safety – The gate to the play area is in need of repair. Cllr King will undertake the repair. The bin adjacent to the pavilion fills with water after rainfall making it difficult to clean out. Holes will be drilled in the bottom to allow rainwater to drain. There are bolts loose in the main apparatus: Cllr Richards will repair.
