### **Flood Warden Report**

The scheduled February meeting between the Environment Agency (E.A.), Southern Water (SW), Highways and East Sussex County Council (E.S.C.C.) Sally Ann MP and chaired by Chris Saint went well. The contents of the previous E.A. presentation had been updated which indicated that the volume of water trying to pass through the Calvert, compared with that being diverted across the reed bed, was not so great as previously reported.

However, it was noted that surface water flows entering the catchment area directly via the Fairlight Cliffs and Pett Level areas were greater than originally estimated. As a result of these new findings the meeting agreed that a full catchment hydrology review is now necessary before proceeding further. This will include areas in Guestling and behind Took Rock.

The EA agreed to provide the scope of the proposed survey to the ESCC and via SW, an estimate of costs will be obtained to undertake this survey.

It is anticipated all funding will be sourced by one, or all utilities attending the meeting and ESCC will continue to act as the lead authority.
